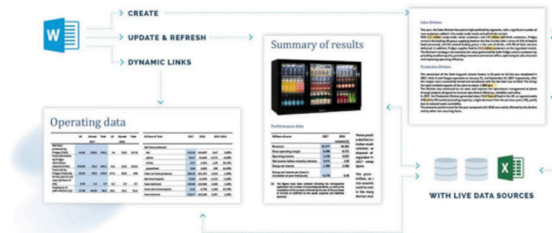
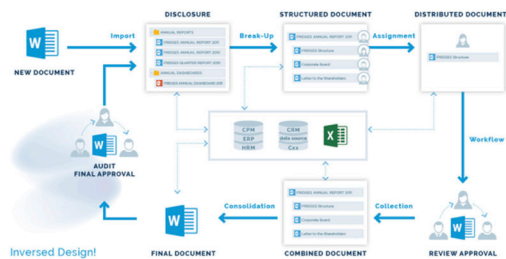

The Anaplan platform offers

Anaplan Disclosure Management application produces enterprise-grade, audit-ready reports and enables users to:

- Create financial and other documents that meet internal and external requirements such as board books, 10K, 10Q, annual reports, ESG reports, and more
- Integrate data from multiple sources into the same document
- Perform automated, un-attended synchronization of documents with data coming from external sources
- Allow concurrent activities on different parts of a document, including co-authoring of shared document sections
- Automate workflow and notifications from creation to approval and distribution
- Manage and compare multiple versions of the same document
- Feed different iXBRL and ESG tagging tools
- Enable dynamic text, data and table updates, and roll-forward and push-down functionality
- Apply financial intelligence to collected data, like scaling, rounding, currency, etc.
- Check data consistency across different documents and/or different paragraphs, sections, within the same document
- Manage user permission, audit trails, and version control
- Publish documents in different formats like HTML and iXBRL



- **Compliance:** SOC1 Type II and SOC2 Type II audits were done by an attested 3rd party auditor. These assess Anaplan controls related to security, availability, processing integrity, confidentiality and/or privacy. SOC2 is AICPA standard for reporting on controls at service organizations, including SaaS, that is audited annually by an attested 3rd party auditor. Anaplan Disclosure Management entity has been verified SOC2 type II compliant.
- **GDPR:** Anaplan complies with all European Union's General Data Protection Regulation (GDPR), which protects data subjects' fundamental rights to privacy and the protection of personal data.
- **Azure:** Anaplan Disclosure Management application solely operates in Microsoft Azure data centers that have been certified in ISO 27001 and PCI/DSS Service Provider Level 1. These data centers are also a certified platform for applications with Authority to Operate (ATO) under the Defense Information Assurance Certification and Accreditation Program (DIACAP). Data centers are located globally with physical locations in North America and Europe. European customers are hosted in EU-based data centers as required.
- **Advanced enterprise authentication mechanisms:** To prevent Cross Site Request Forgery (CSRF), Anaplan has a highly secured session-ID tracking mechanism that monitors whether an authorized user is the initiator on any requests. Anaplan supports access through its two-factor authentication Azure Active Directory or the Federated Authentication for Single Sign-On (SSO).
- **Integrity of backups:** Customer data is continuously backed up and can be restored to the minute during the backup retention window. If data is lost in one Azure data center, data is automatically restored in a geographically distant Azure data center within an hour. Anaplan tests the integrity of the backups periodically.
- **System availability:** Anaplan leverages Microsoft Azure Cloud to run its infrastructure, providing a 99.5% uptime SLA. Application regional failure is handled through DNS and region replication functionality provided by Azure. System performance metrics are monitored to ensure consistent performance level for all users. Anaplan securely deletes customer data after the data retention period and is compliant with NIST 800-88 for data destruction standards.
